All introduced themselves.

2. Apologies for absence:

Colin Brown appointed to post of Director Campaigns & Political Engagement.

7. Campaigns/Priorities:

NC report of the Political Unit

This version: 2018 04 03

Here's a summary of a number of projects the Political Unit has been working on since the February 2018 meeting. As always, the letter denotes the category of the priority and the number gives a rough guide to its level of priority within each category. Some items are not included, as there's nothing sufficiently major to report, which is why the numbering jumps forward in some places.

At the end of the NC meeting we will establish the priorities for the next two months. The Political Unit now consists of Colin Brown (Director of Campaigns & Political Engagement) and Lembit Öpik (Director of Communications & Public Affairs) so the team is back to full strength.

A1 Clean Air Zones (CAZs)

CAZs represent the greatest threat to the internal combustion engine in the history of road transport. Emissions targets are being used to set limits on where powered vehicles may go, and we are in the firing line along with all other conventionally powered machines. MAG needs to decide what to do about this. The Political Unit proposes a choice between three options:

- 1 Do nothing in which case we will be banned together with all other users of private transport powered by the internal combustion engine (ICE).
- Campaign for an exemption for powered two wheelers which, at best, would give us a 'stay of execution,' meaning a little longer to abandon our ICE powered machines. At worst, it will do nothing and we will be banned along with the other vehicles at the same time. Lembit believes this latter scenario is more likely than the former.
- Form an alliance with other ICE users facing prohibition and work together to campaign for parity of treatment with hybrid and all-electric machines. Note that electric vehicles are ecologically flawed and we can moint an effective campaign by highlighting the scientific inconsistencies in the current policy agenda. Ultimately, this could lead to a court case based on discrimination.

The Political Unit recommends Option 3. We recognise others propose Option 2. We would like the NC to determine which option is to be pursued – or to provide a fourth option for us to follow. Dozens of local authorities are already adopting the CAZ model, and the list of local authorities is likely to expand very quickly. We need to act - or be prepared to accept the risk of being banned.

- Colin is trying to influence Transport for West Midlands to use the Northampton model for West Midlands. This model recognises the modal shift benefits of powered two wheelers for congestion and pollution.
- We continue to seek data on emissions for like-for-like journeys on PTWs versus other modes to make a coherent assessment of this.
- The CAZ policy document is ready and available to NC.
- Colin is overseeing the comprehensive list of the areas at risk of CAZ implementation and he's identifying
 the policy towards powered two wheelers in these areas, now totalling 60 local authorities since the 3rd legal
 ruling in March.
- London is a leading location for our campaigning work regarding the CAZ threat, with motorcycles and other road vehicles set to be banned in Islington where Bike Shed is based from July 2018.
- We now have data on the environmental damage electric cars create, but we need more and this is a priority for our research.
- Lembit has spoken with Tony Cox about shortcomings relating to catalytic converters, which are compromised in traffic and at low speeds due to the burn temperature in the engine.
- We are planning to create a leaflet to send to all MPs about the issue, with a cover note from the MAG Chair. Michael Armstrong will test the leaflet with his regional MPs who aren't yet MAG members.

• We are appealing to members to write to MPs to challenge CAZs – and also to councils which tend to be leading on this. This needs to be assessed in the light of what the NC decides on the issue.

A2 Crime and Home Office interface

16,000 motorcycles were stolen in London alone last year. We Ride London held a successful demonstration in March, and there is a lot of energy for getting solid action from the authorities on the crime epidemic.

- Colin is leading our work on crime, with Tim Fawthrop heading up matters in London. Steve Bolton continues to contribute too.
- Colin has been in touch with the Home Office to agree our involvement on the Home Office Round Table 'working groups.' It looks like we'll have to take quite a proactive approach in this regard, which Colin will explain at the meeting.
- Colin is also engaging with Tony Campbell (MCIA) and Craig Carey Clinch regarding the creation of a shared policy position, bearing in mind the industry's frustration at being blamed for not doing enough to tackle the problem.
- As previously mentioned, Keith Prince (GLA) suggested a crime phone number and we can pursue this
 when Tim meets Keith again, which both have agreed to do.
- Colin is trialling a security awareness event crime hotspot areas in the UK. This will be run in partnership with police forces giving the opportunity for bikers to air their concerns directly to the police, and promote MAG's work and initiatives locally and nationally
- Colin is also exploring corporate membership/member benefit deals with selected potential partners that relate to the crime issue.

A3 Cradle to grave analysis

In keeping with the need for solid data on the true effect of different vehicles upon the environment, we're finishing up the work we started last year on this definitive analysis of emissions from building, operating and disposing of different vehicles.

- Colin is assessing the data we've got so far and the work we must now do to complete it. He met with MCIA in Coventry, which had only limited use we'll have to generate the answers for ourselves.
- Colin will finish this up with Alex Bridgwood.
- Success is to prove that motorcycles produce less pollution than vehicles which are proposed to be exempt
 from the charges in London, and therefore potentially elsewhere. This could prove very important should we
 take the matter to Parliament or court.

A4 PRs and media

Colin's arrival has increased the news output because there's even more to report now. We always welcome suggestions for PRs – so please do suggest them, using the letters 'PR' as part of your email's title.

- We're generating PRs on a regular basis.
- Lembit visited The Editor of The Road in March to finish up the campaigns and some other pages. It's set to be a great edition.
- Subjects for PRs include: ULEZ; Clean Air Zones.
- Colin attended crime event in the North and generated a PR for that.

A5 Consultations

There's a continuous flow of consultations local and nationally. We've found an efficient way of keeping up to speed with them, and Colin has already made his first submission to a London consultation. George Legg is a fantastic asset in keeping tabs on what's coming through the consultation pipeline.

- Lembit is meeting Iain Stewart MP, who's heading up a Prime Minister approved project involving Oxford and Cambridge on hi-tech, part of which relates to transport. Both risk banning vehicles from the centre of their cities and Lembit expects to clarify the Government's perspective on this sort of initiative. This meeting is on 18th April 2018. Lembit will then ask for a meeting with the Oxford Council proposers of the traffic ban. Gareth in Reading will also be involved in this.
- The latest ULEZ submission was submitted by 27th February 2018, as scheduled. This is on-going work and they don't' seem to be listening but the fact we've made our submissions clearly and with data may become very important as matters progress towards a potential legal challenge.
- MCIA and MAG are in regular talks about the TfL positon on charging.
- Following talks with Tony Cox, we're assessing the case for submitting some Parliamentary Questions
 regarding low speed vehicle operations and Euro 6 emissions levels, as the technology may not be effective
 in those conditions. That means these 'ULEZ exempt' vehicles could be pumping out more emissions than
 non-exempt ones.
- Some superfast research work by Colin/Lembit meant we got a MAG submission to the 'London Draft Plan' in record speed.

A6 GLA

Our relationship with the GLA Transport Committee is strong and stable. Its Chair, Keith Prince, is a good ally to MAG's agenda and he has arranged to meet the Mayor to discuss matters of concern to MAG.

- Colin is organising a MAG reception at London City Hall, hosted by Keith Prince. The theme is access to
 bus lanes (so we'll be inviting representatives from the London Boroughs) and also ULEZ charging and our
 concern for PTWs (so we're inviting the relevant individuals from the GLA and TfL). We'll be seeking
 sponsors, including businesses, MCIA. Lembit is working on the costs.
- MAG arranged for the MCIA to share its Motorcycle Framework which MAG endorses with Keith Prince.
 This meeting occurred on 29th March 2018 and appears to have gone very well. This helps to solidify the shared messages on biking in a wholly constructive manner.
- Tim Fawthrop and Colin are managing the 21st April Demo. One option for the demo is the '1 for 1' policy of showing how, if we're paying like cars, we'll take up a car space each. Other options for further demonstrations include wearing helmets on Public Transport and calculating the miniscule emissions created by the demo itself.
- We Ride London had a well reported demo in March, but it's likely the demonstration path will be primarily
 the responsibility of MAG from now on. We Ride London said that, from here on they will support MAG
 events and they'll focus on writing campaigns instead.

A7 Parliamentary Reception

Stephen Timms MP has offered to host a MAG reception in Parliament about motorcycle crime. This is a big issue for the Home Office and we're likely to secure a Minister to speak at the event too.

- Colin is leading on organising the reception and timetable for the MAG reception in British Parliament, hosted by Mr Timms MP. The focus will be biker victims of crime, public victims of crime and how to reduce these effects. We are considering whether to combine this with a lobby of Parliament.
- We're seeking sponsors to address cost of reception. Squire, MCIA and MCRG are all options. Lembit is finding out the costings via Parliamentary estate. The target reception date is June or July 2018 and if that's not feasible as soon as possible after that.

A8 Membership Drive Amongst Politicians

Lembit is pursuing the signing up process. The aim is to maintain a steady strain in recruitment. Lembit has submitted a feature on new member Keith Prince in The Road which is available at the NC meeting.

A10 Potholes and manhole covers

Lembit has been assisting those who are contacting their local authorities about road surfaces. We've also raised this as an agenda item at the Highways England meetings.

- The Political Unit has been working with Tim Peregrine in his area to see if we can get action by the local
 authority regarding slippery manhole covers. We've also made contact with Preformed Markings to ensure
 we've still got a favourable financial relationship with them when we direct business in their direction.
- We're keen to roll out an action plan to engage with local authorities and utility firms on the matter and seek a lead activist to progress this campaign.

B2 Radio profile

A lot of members have been on the radio recently, including Tim Fawthrop, Steve Mallett and others.

- We continue to encourage activists to promote MAG on radio phone-ins.
- We're creating a simple 'how-to-get-on-air' guide for activists and are happy to provide a short media training session for members.

B4 VMCC

Lembit has repeatedly contacted VMCC, and is hoping to meet them at the Classic Bike Show on the weekend of 21st-22nd April.

We need to confirm who'll attend the VMCC meeting. If the group is represented at the show, Lembit might
be able to do it there. Otherwise, it is likely to be handled by The President, Colin or another individual such
as Steve Mallett.

B6 Highways England

There's a full write up of the most recent developments at the most recent Highways England meeting in The Road.

- Lembit and Colin attended the meeting on 13th March 2018.
- The next one is 17th April. Lembit will attend.

B3 Events

Colin and Lembit are sharing the events attendance portfolio effectively.

- Lembit attended the Event City show in Manchester: 23-24 March 2018.
- Lembit will attend the Classic bike show: 21st April.

C2 ULEZ Action Day April 2018

The London MAG group is organising a major demo on 21st April 2018 in London, entitled, 'Motorcycle Matters.'

- Tim Fawthrop is leading on this with support from Colin Brown.
- Speakers are being organised, and the President as well as the Chair are expected to address the demo.
 MPs are also being invited.

C4 PACTS

Lembit attended PACTS meetings, 8th March in Parliament. Some useful info was available there. It's a safety orientated committee, and we get to see the thinking of the authorities by attending.

C5 Silvertown Tunnel

MAG awaits the decision on charging for the proposed new Silvertown crossing of the Thames. This is expected in May 2018, and will have great importance regarding whether motorbikes are charged or not. MAG submitted a comprehensive case opposing such a charge and we await the verdict of the Department for Transport.

Lembit Öpik & Colin Brown

Motorcycle Action Group

CB opened his report to the meeting by noting that Clean air Zones (CAZs) are a big threat to motorcycling, with many proposed and some already approved. There will be two types: charged and uncharged and the number of Zones mandated so far has reached 62.

London's ULEZ is going ahead with no progress in engaging with TfL, who are not listening. MCIA is not on board with fighting this issue, although it acknowledges that "MAG is right but this ship has sailed".

The cradle-to-grave vehicle analysis is ongoing.

We have reached a point in respect to the internal combustion engine (ICE) where we have to decide on the way forward: do nothing, go it alone, work with others, or some other way.

AC noted that if MAG was to align with other organisations it would have to be selective. RM felt it is a single-track vehicle issue that should not be diluted. TP agreed but felt it may be appropriate to work with other, similarly-minded organisations. AC said that the issue is about protected personal transport delivery, whatever that might be. Following further discussion, JC provided wording for a motion on the way forward:

To robustly promote powered single-track vehicles as part of the solution to transport congestion and environmental issues. In addition, to consider strategic alliances with other organisations where their mission complements MAG's brief.

Proposed: Richard Manton; Seconded: Steve Wykes. Carried.

CB then reported that response to an FOI request to all Police forces has been "patchy". In addition, Bikesure has provided some information based on insurance claims, which is useful as a guide but cannot be used as official statistics.

Following Hull force's Operation Yellow Fin, it is clear that forces are not sharing best practice, highlighting the importance of engaging with as many forces as possible, as the approach among forces is inconsistent.

Negotiations are in progress with Crime Stoppers regarding the "MAG Protected" scheme and it is hoped to offer a package.

Consultations and parliamentary receptions are ongoing. Problems with potholes and manhole covers are ongoing and should be reported to the relevant Councils.

CB noted that it is easy to raise profile via radio by ringing in to shows.

Road structure planning has been shown to consider PTWs in exactly the same way as cars.

The April 21st "Motorcycles Matter" demonstration in London was described as an "ambitious project".

A decision regarding the Silvertown Tunnel project is pending.

8. Board meeting report (including FEMA):

Apologies received from TC and PD. No appointments or resignations. Minutes of previous meeting accepted. Action Point: AC added as Director. Clubs pack nears completion. Training feedback to follow. Report from JS.

A contra-deal in respect of The Scottish Show has been approved.

There is no movement in respect to IT matters and the website.

IC attended FEMA, and also gave a presentation about GDPR.

Vision Zero is on the FEMA agenda.

The Foundation held an AGM in February and new Trustees have been registered apart from Debz Rose.

The Lock2Lock campaign is moving forward and the Foundation is working on this.

IM has been tasked with finding a Director for MAG Media.

There are no issues for NEL.

The political team priorities were clarified.

There are potential member benefits in the pipeline.

The deadline for GDPR is approaching and the database is being brought into line with new regulations and there may be a requirement for separate insurance for this. Old membership lists must be destroyed.

Greater London: Tim Fawthrop

Secured a stand at the Excel bike show, with the help of Steve Mallet and other volunteers we managed to put together a great presence. We signed up and renewed nearly 30 people, but the focus was trying to get people to go online and fill in the TfL consultation on the ULEZ extension because it affects everybody.

Saturday unable to attend the NC and submitted my report.

Organised and led the Fred Hill run after helping Peter who had a stand at their Motorcycle Awareness Day (MAD) event, organised some photos for the road and talked to Bike Safe etc, Attended MAG at the Bikeshed, this venue is ticking along nicely and depending on the weather can have anything between 2 and 15 people attending.

Hampshire Road Safety Council Meetings

There are three of these held in the County, although core members or organisations are continuous, occasionally there are subtle changes at the meetings.

I attended the Central meeting with Richard from Portsmouth attending the Southern meeting. Generally a routine meeting however motorcycling came up a couple of times.

- The new Fire Safety officer informed the meeting he was a keen motorcyclist.
- Hampshire & Thames Valley Road Safety Police Sergeant told the meeting he is a keen rider and shared a couple of observations.
- When questioned by an older councillor on course of action when behind a Fire Engine in full motion, the
 meeting was told that their drivers are taught more roadcraft now compared to 2 years ago, so much
 more ability to read the roads.
- The Councillor chairing the meeting asked if I was aware of the issues raised by CANS. He was at the
 initial meeting of CANS. I was able to share that we attended the same meeting and remain in
 communication; however it was not a discussion for this meeting. Hampshire Police Sergeant was
 supportive of this stance. He had assisted us in contacting colleagues and CANS

Identified Consultations and raised with Members or appropriate Group Reps on: M25 junction 10 to A3 Wisley Interchange consultation Stonehenge Tunnel Consultation.

There has been dialogue with TRF member about this as the proposal also impacts Rights of Ways and reassigning routes. In addition the routes, I am told, higher rates of incident.

The TRF Member in contact has attended meeting with others that include, HE – A303 project manager, Councillors, etc.

Communities Against Noise and Speed (CANS).

Unable to attend meeting, however appears to be losing some steam. Concern is that once the better weather returns, local residents will again become more active. Hampshire Police and Crime Commissioner, a major target of the CANS Group, is under more local fire due to the cuts in Hampshire Police services, however recruiting for his own office and a Police and Crime Commissioner.

The Group Rep attended the County's "South" Road Safety Council meeting, which is positive continuity with the City meeting.

Regional Deputy Rep attend Portsmouth Transport Liaison Group meeting.

The Group have positive social events and

Salisbury.

Whilst there are actual members, it is a struggle to see them at meetings. This is something that was very evident at the recent AGM.

Unfortunately, at the time of writing this, the Spring Surprise Show in the City Centre will not proceed due to a number of reasons, which includes the lack of commitment from personnel.

The Leader of the Council in Salisbury and a Council colleague visited the AGM to show commitment to the event and discuss how they are changing policies to enable events rather than hinder them.

The Group will be discussing plans to host a smaller event later in the year.

Involved in A303 Consultation.

Southampton.

The Group remains quite quiet, however plans for show and other events move forwards.

Moved Venue to a new location which is felt will see improved memberships.

Pursuing contacts in the Council regarding Clean Air Policy in the City.

Group Members very concerned about theft incidents in the City and how it is addressed.

Winchester.

The Group is very small and unfortunately lost one of their Members, however continue to meet and discuss MAG business and plan a small show in the summer.

Decided not to hold their own Show but the members will be supporting other Groups.

South Wales: Phil McFadden (acting)

In a bloodless coup Phil has replaced Rory as acting Regional rep.

Rob recently arranged another Mods & Rockers Run, this time to a steam fair at Pembrey Country Park. Participants in the run paid a donation & were granted free entry to the show (Rob had pre-arranged this with the show organiser, who was happy to help as long as we provided marshals (several volunteers led by Alex Thompson of Brecon MAG)). A contingent from Aberystwyth MAG set up a ride so they could also attend. In total, monies raised amounted to £285 for MAG (towards the cost of this year's AGC) and £200 for the charity Autism Puzzles.

South Wales members continue to actively contribute with stands at various bike shows and at the road safety partnerships' "engagement days", which are seen by all parties as effective in reducing casualties. Uptake by riders in the several schemes in West Wales, including first aid/emergency practice for riders as well as Bikesafe & ERS, has been reducing, and so budgets to these is cut this year: the road safety forum has recognised that other road users are a major factor in incidents involving bikers and so has targeted them for extra training and other initiatives accordingly! Accident figures for bikes last year in Dyfed Powys were lower, with NO fatalities.

Another consequence of our loss of Ian Williamson is that we no longer have anyone as able and available to attend the Welsh national road safety meetings. We hope to address this in the near future. We also have a vacancy for membership secretary, as Simon Walsh has recently resigned due to starting his new business venture - a pub which used to host Cardiff MAG meetings, which also has ample camping space...

A donation of £457.00 was made to Central by North Devon MAG.

Working with Staffordshire Motorcycle Focus Group

My work as part of this initiative continues. Staffordshire road safety can demonstrate a 34.3% reduction in motorcycle collisions over the last 10 years, in comparison with the national average reduction of just 12.6%. This demonstrates that a great deal can be achieved when a level of funding is applied to the issue.

Secure Parking - Birmingham

Birmingham City Council's "trial" of secure PTW parking is getting closer. Latest information is that installation in 4 locations is hoped to happen in May.

Birmingham Clean Air Zone

A frustrating lack of progress in this area. The drawbridge has been raised and no communication happening at present.

Brum Demo

Planning work for the event is ongoing. Camping on the Saturday night for anyone wanting to travel from further afield is now a possibility. Details will be released soon.

Updates

Offices – Main door would not close and was struggling to open with all the wet weather we've had. Site Manager John took a look and planed some wood off where it was sticking, it is better but not perfect. John will return and take the door off as the main problem is on the bottom currently waiting for a dry day. Two radiators were not working, the thermostatic valves had jammed, and both are now working. I will ensure that they are inspected when the boiler is serviced next.

IT – No progression on RR database access for reporting at this point. Leslie has unfortunately had other priorities which has delayed this and he has confirmed that he will complete this task ASAP. New back-up drives have been purchased and are working well. Facebook old sites for MAG groups that are no longer functioning have been requested to be removed, I do not believe that this has happened as yet. Colin has now been set up on the office PC, access to the office server externally is being organised via a VPN. We have had to purchase a laptop to allow this as Colin's was not quite up to the office level especially regarding security.

MAG Foundation – AGM prior to last NC meeting, new Trustees elected. They are currently working on relaunching the Lock to lock campaign and have started a column in The ROAD to communicate to members.

Staff – Carol is up to date and continues to perform to a high standard. Colin joined the team on 1st March, the first day of heavy snow in the Midlands, so was unable to physically come to the office. But that did not stop the work that he started on. This is having a positive effect on Lembit and he feels more so supported. Lembit and Colin are working well as a team and showing positive moves forward in terms of priorities.
